2. We will provide you with one 3x6 table.
3. Signage and displays are your responsibility.
4. Each vendor holds the Champlain Valley Skating Club, Burlington Parks and recreation, and any representatives of such, harmless from any and all liability for injuries and from any and all liability for damages or loss of property.
5. The local organizing committee reserves the right to decline any vendors if the requested vending space is not available before or after the closing date of September 1, 2009. Please return this letter with your signature indicating your acceptance of the above conditions.
